Tenrox Mobile

TE-1871

Added the ability to view notes attached to a time entry through both the My Timesheet and Assigned Timesheets pages. Clicking the Note icon on the Time Entry List will expand to show the notes associated to the time entry. The notes must be set as Public in order for them to be visible on the Assigned Timesheets page.

Work Breakdown Structure

TE-9824

Added Financial Planner upgrade script fixes to the core Tenrox product:

- 1- Corrected order of Deferred Revenue and Recognized Revenue rows
- 2- Corrected row name of "Total Time PO"
- 3- Added the row "Billable Time POC"

TE-9250

Improvements were made to better handle the multiple loading times of the Financial Planner when the values for the Non-Labor and Recognized Revenue cells are entered manually. The change now requires the refreshing of the page. Therefore, upon either the Non-Labor OR Recognized Revenue cells being entered manually, a dialog box will display, above the Financial Planner table, providing instructions to refresh the page by either clicking Refresh in the dialog box OR Refresh at the top of the page. The Financial Planner will ONLY load provided the page is refreshed, as instructed, otherwise it will not load.

Resolved Issues

This section lists resolved issues included in [Tenrox 2015 R1 SP5](#)

Expenses

TE-8586

Fixed an issue with Expenses where the Access Denied error was generating upon attempting to copy expense entries using the “Copy From this expense report” option. This was a result of the user having a security profile that is not granted the “Can Select unassigned tasks” right. Maintaining the security profile right as is, the applied resolution will show only the assigned tasks during the copying process.

Financials

TE-9293

Fixed an issue with Expense Payable Batches where cash advance expense item entries were being excluded from the payable batch, specifically when there are no other expense entry types within the same expense report. The applied resolution requires that any existing batches have to be regenerated, while any new ones will now correctly include cash advance entries.

TE-9332

Fixed issues with the Invoice Manager and Multi Client Invoice Manager where on generating an invoice, the client currency was being used, instead of the invoice currency. Moreover, on creating an invoice, when selecting a currency and/or company, neither the Rate to base currency nor the Rate to company currency were refreshing, as expected. The applied resolution required modifying the stored procedure, and having the rates properly refresh upon the currency or company being selected. In addressing any existing invoices, it is required that they be deleted and regenerated.

Home Page

TE-8794

Fixed an issue with the Home page where the count of the assigned timesheets, within the My Assigned Items frame, was not correctly corresponding to the actual number of assigned timesheets for the logged user who does not hold the Administrator security profile. The applied resolution has the displayed assigned timesheets number accurately representing the true count.

Organizational Breakdown Structure (OBS)

- TE-7771** Fixed an issue with Roles Import where the import process was timing out when attempting to import a large number of records, and no log was being returned. The applied resolution required improving the process and frequency of the status request from the server for the import process.
- TCU-498** Fixed an issue with the upgrade scripts where, on upgrading, data, containing French characters, were resulting in them getting corrupted. The applied resolution required changing the upgrade encoding and data files for specific streams.

Reporting

- TE-8571** Fixed a performance issue with the Capacity by Role report where it was timing out on attempting to generate results, which was due to large amounts of data being retrieved. The applied resolution allows proper generation of the report regardless of the size of the data.
- TE-9008** Fixed an issue with the Upland Analytics Repots where the Previous navigation arrow of the Calendar, for the Entry Date parameter, was not displaying. The applied resolution has the Calendar navigation arrows displaying as expected.
- TE-9009** Fixed an issue with an RDLC Report where it was impossible to key-in the date for a date parameter. The applied resolution now allows the option to enter a date in any date box by either keying it in or making a selection from the corresponding Calendar.

Resource Management

- TE-8560** Fixed an issue with the processing of Holiday Sets where Non-working holiday time entries were being created within associated users' timesheets that were outside the holiday date range. The applied resolution corrected the processing to now have the holiday time entries be created on the proper dates.
- TE-9222** Fixed an issue with the Work Plan where the list boxes were not properly filtering upon editing a booking. The applied resolution required modifying the condition for the list box so that it filters accordingly.

Salesforce Integration

- TE-8713** Fixed an issue with the Salesforce and Tenrox integration where the "Project Payable Amount" KPI was not loading from the resource file. The applied resolution required correcting the mapping of the Salesforce "Project Payable Amount" to Tenrox.
- TCU-503** Fixed an issue with the Salesforce and Tenrox integration where a notification was not generating, as expected, upon having exceeded the maximum number of allowable characters in an entry box. Moreover, deleting some characters and entering others, even within the allowable limit, was prohibited. This was due to the length of the Filter box under the CRM Advanced Options page not properly overriding the setting for the text box customized control. The applied resolution required changing the filter length to 4000.

Security

- TE-8121** Fixed an issue with the upgrade scripts where any newly added menu option to the application, such as the Roles menu option, was only being added to the personalized User Menu once the "Override Global Settings" option had been cleared and then selected again.

Tenrox Project Plan (TPP)

- TE-9006** Fixed an issue with TPP where the Work type was not successfully loaded as a result of no existing license for the Funded attribute in the environment wherein the Work Types were created, therefore the Funded attribute was saving with a Null value.

Timesheet

- TCU-476** Fixed an issue with Timesheet Adjustments where upon copying an adjustment entry row, then attempting to enter a corresponding time, was generating an error. This was the result of the Assignment ID having been incorrectly loaded in the Task list box upon the Adjustment having been copied. The applied resolution corrected the behavior to have the Task ID properly load for the Task list box.

TE-9506 Fixed an issue with the Timesheet where the ETC box was not successfully saving a zero value entry, as after entering a zero and refreshing the timesheet the previous value would just redisplay.

Work Breakdown Structure (WBS)

TE-7543 Fixed an issue with Project Cost Rules where changing the Effective End Date of an Hourly Cost Rule to "Open Ended" was not successfully saving as the date value was setting it to the current date instead.

TE-9025 Fixed an issue with the Client POs, accessed through the Client Edit page (Setup > Work > Clients > Client Edit), where the page was not loading due to corrupted data. The corruption was occurring when the Client-Invoice data was being imported into Tenrox. The applied resolution required running a script to correct the corrupted data and a DLL to prevent setting the incorrect data in the database.

TE-8583 Fixed an issue with upgrading wherein the override option for the forecast rate that was set in the previous version was not being set in the same manner in the upgraded version.

TCU-455 Fixed an issue with the Financial Planner where an error was triggering, when attempting to override the Forecast setting at the project level, as a result of a stray null value having been returned due to a Role that was not successfully completely deleted from the database.

TE-9728 Fixed a rounding issue in the Financial Planner wherein the Recognizable, Revenue Subtotal, and Total Cost at the Grand Total Level were not corresponding with the Available Budget (Billable /Cost).

Work Processes

TE-9501 Fixed an issue with Work Processes where uploading any file as an attachment was impossible due to their extensions having contained capital letters.

TE-4322

Fixed an issue with Leave Requests where approving a Leave Request resulted in the duplication of the corresponding time entry. This was occurring when the approver mistakenly or inadvertently closed the Leave Request page before being able to actually approve it. But, even with it still being in the Submitted state, a non-working time entry was nonetheless created. However, on reopening the request page again and actually approving it, the non-working time entry was duplicated. The applied resolution required adding a validation wherein upon a leave request being approved there is verification of any existing non-working time entries associated to the given leave request and if so it will be deleted and another one created, eliminating any possible time entry duplication.
